Pursuant to Section 11-04-088 of the Centerville Municipal Code, all excavations within the Public Rights-of-Way shall be bored and pot holed rather than open cut, unless prior approval is obtained for open cutting at the time of issuance of the Excavation Permit. All Open Cut Permits shall be reviewed and approved by the Public Works Director, with the review and recommendation of the City Engineer. All approved open cuts must comply with the provisions of the Centerville City Excavation Permit Ordinance, as set forth in Title 11, Chapter 4, of the Centerville Municipal Code ("Excavation Permit Ordinance"), and other applicable ordinances. It is unlawful for any person to make an open cut within the Public Rights-of-Way until and unless an Open Cut Permit has been issued for such work. Please type or print clearly in black or blue ink and fill out this entire application completely and accurately. If questions are not applicable, enter "NA." Do not leave questions blank. Be sure to sign the application when completed. Centerville City is a political subdivision under the laws of the State of Utah. This application becomes a public record and may be subject to disclosure under applicable provisions of the Utah Government Records Access and Management Act.
